### NOTICE INVITING TENDER TENDER ID: 2022\_CSIR\_117019\_1

- 1. Online item-rate tenders are hereby invited through e-tendering portal https://etenders.gov.in for the work of "Annual maintenance contract for operation and routine maintenance of 11 KV Sub-station, DG Sets, pump house including internal and external electrification, HT LT Panels, distribution boards, internal telephone wiring and maintenance & servicing for A.C. units etc. in office and guest house campus at CSIR-HRDC, Ghaziabad" from the firms having worked with CPWD, Railways, MES, Post & Telegraph Deptt., State PWD's, Semi government organizations or those who have successfully carried out works for CSIR or its laboratories and have successfully completed at least three similar works amounting to 40% or at least two similar works amounting to 60% or at least one work amounting to 80% or above in single contract of the estimated cost of work during the last seven years. The contractors may apply with proof of fulfilling the above conditions along with copies of PAN Card, EPF, ESI and GST registration number and satisfactory work completion certificates and valid electrical license.
- 2. The Estimated cost of work is **Rs. 40,21,052**/- (**Rs. Forty lakh twenty-one thousand fifty-two only**) based on prevailing market rates including EPF, ESI, GST, uniform and labour-cess.
- 3. Duration of contract for carrying out of the work will be **365 Days** from the date of commencement which shall be reckoned from the tenth day of issue of award letter.
- 4. The tender in two bid system shall be submitted through online at CPP-portal website <u>https://etenders.gov.in/eprocure/app</u> by the tenderer, as per date given in Critical Date Sheet below:

#### **Critical Date Sheet**

5. Scanned copies of <u>Tender Fee (non-refundable) of Rs. 500/- (Rupees five hundred only) and</u> <u>Earnest Money Deposit (EMD) amounting to Rs. 80,500/- (Rupees eighty thousand five</u> <u>hundred only)</u>, deposited through RTGS / NEFT in favour of <u>Human Resource Development</u> <u>Centre, Ghaziabad (Saving Account No. 30269531421; IFSC Code-SBIN0007873 of State Bank</u> of India, Raj Nagar, Ghaziabad, Uttar Pradesh - 201002) shall be uploaded in cover –I of the tender. Tenders received without tender fee and Earnest Money Deposit will not be considered.

- 6. The tenderers are to indicate the name & telephone numbers of issuing agency of the completion certificates to enable the verification of the document, if necessary. It may be noted that even after opening of price bid, the credential submitted found to be false / forged the offer submitted shall be rejected outright. No further clarification will be sought from the tenderers.
- 7. The employer does not bind himself to accept the lowest or any tender and reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to Perform the same at the rates quoted by him.
- No tenderer shall be permitted to tender for works in the concerned unit of C.S.I.R. in which a relative is posted in the grade between Controller of Administration and Junior Engineer, (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or subsequently employed by him and who relatives are as mentioned above.

Note: A person shall be deemed to be a relative of another if, and only if, (a) they are members of a Hindu undivided family or (b) they are husband and wife or (c) the one is related to the other in the following manner: father, mother (including step mother), son (including step son), Son's wife, Daughter (including step daughter), Father's father, Son's son, Son's son's wife, Son's daughter, Son's daughter's husband, Daughter's husband, Daughter's son, Daughter's son's wife, Daughter's daughter, Daughter's daughter's daughter's husband, Brother (including step brother), Brother's wife, Sister (including step sister), Sister's husband.

- 9. Tenders submitted shall remain valid for a period of 90 days from the bid submission end date for the purpose of acceptance and award of work. Validity of the tender beyond 90 days from the bid submission end date shall be extended by mutual consent.
- 10. In e-tendering, tenderer can quote the rates in figure only. The rates in words, amount of each item and total is generated automatically. Therefore, the rate quoted by the tenderer in figure is to be taken as correct.
- 11. The tenderer should carefully see the contract drawings (as applicable) as no claim whatsoever will be entertained for any alleged ignorance thereof.
- 12. Before tendering, the tenderer shall inspect the site to fully acquaint himself about the conditions in regard to accessibility of site, nature and area/extent of ground, working conditions of site and locality including stacking of materials, installations of tools & plants etc., conditions affecting accommodations and movement of labour etc. required for the satisfactory execution of contract. No claim whatsoever on such accounts shall be entertained by the Employer under any circumstances.

- 13. If any tenderer withdraws his tender within the validity period or makes any modification in terms and conditions of the tender, before the award of work, which are not acceptable to CSIR-HRDC then CSIR-HRDC shall, without prejudice to any other right or remedy, shall be at the liberty to forfeit 50 % (fifty percent) of the Earnest Money deposit absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process for this work.
- 14. 100% Earnest Money will be forfeited if the contractor fails to commence the work within the stipulated period after the Award of the work.
- 15. Except writing rates in figure only, the tenderer should not write any conditions or make any changes, additions, alterations and modifications.
- 16. Some of the major provisions of General Conditions of Contract are given below. Interpretations, however, shall be as given in the General Conditions of Contract.
  - a. **DEFECTS LIABILITY PERIOD** is of **NIL** Months from the date of completion as certified by the Engineer-In-Charge.
  - b. Minimum value of work for the intermediate certificate: Interim certificate will be Rs. 2.0 Lakh. However, a lesser amount can be admitted for intermediate / interim certificate at the discretion of the Engineer-In-Charge.
  - c. SECURITY DEPOSIT: A sum @ 10 % of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum along with sum already deposited as earnest money, amounts to 5 % of the tendered value of the work In addition, the contractor shall be required to deposit an amount equal to 3 % of the contract value as performance security as per CPWD Om vide no. DG/CON/Misc./20, dt. 31.12.2021 within the period prescribed in the letter of award issued to him. After recording of the completion date for the work by the Engineer-in-Charge, the Performance Security shall be returned to the contractor, without any interest.
  - d. **COMPENSATION:** Contractor shall pay, as compensation, an amount equal to one percent or such smaller amount as Employer (whose decision in writing shall be final) may decide on the cost of whole work as shown in the agreement, for every week that the work remains un-commenced or unfinished or due quantity of work remains incomplete after the scheduled dates. Compensation to be paid shall not exceed ten percent of the contract amount as shown in the agreement.
- 17. For any queries relating to the Tender Document and the terms and conditions content therein should be addressed to In-Charge, ESU, CSIR-HRDC, Sector- 19, Central Govt. Enclave, Kamla Nehru Nagar, Ghaziabad-201002.
- 18. Clauses No. 28 of General Conditions of Contract i.e. "**ESCALATION**" will not be applicable in this work.
- 19. Deduction of Security Deposit, Income tax, GST tax, labour-cess and all other applicable taxes (if any) by Govt. of India will to be made from the bills.
- 20. Opening of Technical Bid (Cover. I)

(a) The Technical bid will be opened by Tender Opening Committee (TOC) on **02.06.2022 at 03.30 PM**, in the office of In-Charge, ESU, CSIR-HRDC, Sector 19, Central Govt., Enclave, Kamla Nehru Nagar, Ghaziabad-201002 in the presence of such intending tenderers or their authorized representatives who may wish to be present at that time. No claim or any grievances will be entertained what-so-ever by the Tender Opening Committee in this regard.

(b) The TEC, after evaluation of documents contained in Cover-I i.e. Technical Bid, will decide the eligible tenders, as per the criteria laid down in the NIT.

(c) The TOC will then open the Financial Bids of only eligible tenderer.

#### 21. Opening of Financial Bid (Cover- II)

The Cover-II of Eligible Tenderers shall be opened serially. The total amount quoted by the tenderers shall then be read out by the TOC for information of those present / participated.

#### **22.** Tender Liable for Rejection.

#### Tender is liable for outright rejection if on opening it is found that:

- (a) The Tenderer has not strictly followed the procedure laid down for submission of tender.
- (b) If the tender is CONDITIONAL.
- (c) If the Tenderer has quoted his offer anywhere else other than specified place provided.
- (d) The Tenderer has not uploaded the documents or Failed to fill the prescribed format.
- (e) Any other ground as decided by the TEC in view of deviation from Tender Document.

# (f) Any kind of exemption i.e. NSIC & MSME are not allowed, if found exemption certificate, tender will be rejected without any prior notice.

- 23. The instructions for the submission of e-tender are available on the CPP portal i.e. <u>https://etenders.gov.in/eprocure/app</u> under the "Instruction for Online Bid Submission". All the intending tenderers are requested to go through these instructions before entering into the process of e-tendering and advised to visit again CPP website regularly till closing date of submission of tender for any corrigendum / addendum / amendment.
- 24. The scanned copy of **Tender Acceptance Letter "Annexure-I**" on the firm letter head and **Performa to be submitted by applicant "Annexure-II** shall be uploaded in Cover-I.
- 25. Head, CSIR-HRDC reserved the right to reject any or all the tender in part or full without assigning any reason (s) and he also reserves right to take any undertaking (if require) from the tenderer.
- 26. Tender will be accepted only on online CCP Portal. Offline / manual tenders shall not be accepted.

- 27. The contractor shall quote their rates inclusive of EPF, ESI, GST, T&P, Labour-cess and uniform etc.
- 28. The deployed manpower engaged on campus shall be given one weekly leave and relievers shall be deployed accordingly. Overtime shall be acceptable only in any kind of emergency case (sickness etc) and not otherwise. If any such case of overtime comes to notice, the Engineer-in-Charge has full right to take actions accordingly.
- 29. The contractor has to pay the current prevailing minimum wages issued by the Chief Labour Commissioner (Central), New Delhi time to time and no additional amount will be paid on this account.
- 30. The payment to the workman's engaged by the contractor is to be paid through NEFT / RTGS / Account transfer on or before  $7^{th}$  of every month.
- 31. The contractor shall submit the monthly bill along with attendance sheet, receipt/proof of salary payment to workers as per current minimum wages, detailed salary summary and copy of paid contribution of ESI & EPF.
- 32. Uniforms is to be provided to workers while on duty. Minimum Two sets of uniforms including shoes (Additional **Full Sleeves Jacket in winter season**) would have to be provided at the start of the work so that the worker is always with neat and tidy uniform. It will be strictly monitored & compulsory.
- 33. The workers engaged by the contractor / agency shall be at the risk of contractor and in case of any untoward incident, accident, the contractor / agency will be liable for such risks and the department will not be held responsible in any way for such mis-happening and untoward incident. It should be the duty of contractor to adhere to all security precautions as specified with industry by Govt.
- 34. **Electrical License**: The contractor shall have to submit the valid electrical license during applying of tender, issued from the Competent Authority in the name of the firm / contractor *(under renewal application of electrical license will be not applicable)* and also they shall have to possess electrical license issued by any state Govt. under clause 45 of compilation of rule of Indian electricity rules 1956 or as amended from time to time. If the work is awarded to the contractor having license of some other state. The contractor shall have to submit the electrical license of the state Authority where the tender has been applied within three months from award of the work. After award of work contractor shall keep valid license throughout the period of contract by getting it renewed at suitable intervals and submit an attested copy of the same to the department. In the event of any discontinuity invalidity of electrical license of the contractor, its contract is liable for termination.
